Still, initial assessments suggest that the bill boosts employer-based and private-market telehealth coverage but may leave gaps for Medicare and Medicaid users.

### TRC Resources: Proposed 2026 PFS Fact Sheet

“On July 14, 2025, the Centers for Medicare and Medicaid Services (CMS) released their proposal for the 2026 Physician Fee Schedule (PFS). Each year, the agency uses the PFS to update, change or introduce new policies that will impact the Medicare program for the following year. Unless otherwise stated, the policies will typically go into effect the first of the year. What follows are the proposals that directly relate to telehealth.”

### The Big Beautiful Bill: What Is the Telehealth Impact?

The Big Beautiful Bill, signed into law on July 4, 2025, significantly impacts telehealth coverage through changes to high-deductible health plans (HDHPs) and Health Savings Account (HSA) eligibility. The law permanently allows HDHPs to cover telehealth services before the deductible is met, reinstating and extending a popular COVID-era policy.

This change is retroactive to January 1, 2025, and gives employers the option to reimburse earlier virtual care costs. Beginning in 2026, all Bronze and Catastrophic Marketplace plans will qualify as HDHPs, expanding HSA access and increasing telehealth affordability. The bill also allows fixed-fee direct primary care arrangements—which often include telehealth—to be paired with HSAs, further promoting flexible virtual care models.

However, the bill does not extend Medicare telehealth flexibilities introduced during the public health emergency, such as relaxed geographic or originating site restrictions. It also introduces stricter Medicaid eligibility rules and limits retroactive coverage, which may reduce telehealth access for low-income and rural populations. While a new \$50 billion rural health fund aims to soften these impacts, many experts argue it falls short. Overall, the bill boosts employer-based and private-market telehealth coverage but leaves key gaps for Medicare and Medicaid users.
