NEWS UPDATES

The Looming Telehealth Cliff: What's at Stake and What Lawmakers Are Doing

Unless Congress acts, many of the expanded telehealth flexibilities put in place during the COVID-19 pandemic—including the ability for Medicare patients to receive care at home, audio-only visits, and broader provider eligibility—will expire on October 1, 2025. This so-called “telehealth cliff” would roll back access for millions, especially those in rural and underserved communities.

To prevent this, lawmakers have introduced several bipartisan bills, including the CONNECT for Health Act and the Audio-Only Telehealth Access Act, which aim to make key provisions permanent. These efforts reflect growing recognition that telehealth is no longer an emergency workaround but an essential part of the modern healthcare system. Advocates are urging swift legislative action to protect continuity of care and avoid disruption for patients and providers alike.
